The article reviews parliamentarian activity of Trudovaya Gruppa within the period of 1907-1912 regarding labor legislation issues. Using a wide range of archival record, the author analyses the position of Trudovaya Gruppa concerning highly important spheres of neopopulist activity at the beginning of the XX century show interrelation and interinfluence of left-wing fractions in the III State Duma.
