On the basis of the research the author found that the active dynamics of external and internal factors and their interaction led to the outbreak of the Afghanistan civil war.

Military measures of the USSR adopted for the preservation of the regime does not take into account the possibility of reciprocal support of opposition forces in such scales from the side of the main geopolitical opponent, its allies and the countries of the Islamic world. The Soviet invasion in Afghanistan was not intended to become the transformation of the internal and foreign policy doctrines of the USSR. These and other circumstances contributed to many errors, both strategic and tactical, in the development and implementation of policy in Afghanistan by the Soviet Union. This results in the loss of positions of the USSR (Russia) in Afghanistan as well as in the region of the Middle East in general.

Natural and geographical, ethnic and cultural, as well as geopolitical factors have defined a special significance of the Fergana valley (FV). The natural and geographic conditions of these valley lands unique to the region have made them source of sustenance (survival) for entire Central Asia (CA), which is bound to affect the demographic situation.

Its conflict-prone potential is conditioned by a number of interrelated factors. The most important conflict factors that can play a key role in a likely destabilization of the region can be divided into eight groups. These include social and demographic, historical and political, as well economic factors, the problem of enclaves and water supplies, extremist and terrorist organizations, corruption / criminal activities / drug-trafficking and internal destabilizing factors.

Fight for influence over Central Asia became multi-level long ago. The first level is geopolitical confrontations between such giants as Russia, the US and China in order to strengthen one's influence and positions in the region, which is not to rule out a competition between military, political and regional blocs like the Collective Security Treaty Organization (CSTO), NATO or Shanghai Cooperation Organization (SCO). The second level is regional, i.e. between the countries of CA themselves. The third one is conflicts between political groups inside CA nations. The article analyzes the role of Russia's potential allies – countries-members of the CSTO and SCO in organizing preventive measures to localize most dangerous threats and challenges, including terrorism, drug-trafficking and organized crime.
